

Feedback Action Taken Report

2022-2023

This report is compiled by Madhav Vidhi Mahavidyalaya, reflecting the insights gained from feedback collected from both students and faculty through online and offline channels. The institute carefully assessed the received feedback and identified key concerns outlined in the feedback report. Subsequently, the institute proactively implemented measures to enhance the overall teaching and learning experience.

Feedback:

1. **Continuation of Online Classes:** It was suggested that online classes should be continued alongside traditional offline classes.
2. **Communication and Drafting Skill Enhancement:** A certificate course focused on improving communication and drafting skills for students was recommended.
3. **Professional Ethics Program:** To acquaint students with court procedures and the professional legal environment, a professional ethics program was proposed.
4. **Alumni Engagement:** Organizing alumni meets to strengthen professional bonds and network with former students.
5. **Strengthening Disciplinary Actions:** The need for a more robust disciplinary system with immediate actions on complaints was highlighted.
6. **Competitive Exam Preparation:** Conducting free judiciary and competitive exam classes to better prepare students for various examinations.
7. **Career Guidance Program:** Implementation of a career guidance initiative to make students aware of diverse opportunities in the field of law.

8. **Remedial Classes for Slow Learners:** Conducting additional classes to support the learning needs of slower learners.
9. **Learner-Centric Pedagogy:** Shifting the focus of teaching to be more learner-centric rather than teacher-centric.
10. **Faculty Skill Development:** Initiating programs for the professional development of faculty members to enhance their skills.

2. **Communication and Drafting Skill Certificate Courses:** Implemented certificate courses focusing on communication and drafting skills for student development.

6. **Competitive Exam Preparation:** Conducted free judicial coaching and competitive exam classes to better prepare students for future challenges.
7. **Career Guidance Program:** Collaborated with renowned career counselors to offer comprehensive career guidance, helping students focus on their professional aspirations.


8. **ICT-Based Teaching:** Implemented ICT-based teaching methods alongside traditional modes to enrich the learning experience.
